April Meeting Recap

Debbie Coan, CPA and D. Scot Loyd, CPA from Swindoll, Janzen, Hawk & Loyd, LLC presented on Change – How Do I Survive.

Debbie defined change as becoming different, making someone or something different, or to become something else. Change will always happen and keep happening and sometimes happens immediately. Debbie and Scot both went over the changes they have endured in their own lives and how they have worked through it. Scot described change as something that can eat you alive unless you make something happen.

Scot discussed an article called “12 Tips for Overcoming Your Fear of Change at Work” by Jacquelyn Smith in Forbes Magazine. First acknowledge the change. Not everyone deals with change the same so recognizing and accepting it is the first step to managing it. Additionally, you need to acknowledge your fears and other people’s fears then you can accept your feelings and seek support. Sometimes it’s even good to designate “worry time” to discuss your fears and figure out a way to overcome them so they don’t spill over throughout your day. Scot suggested writing all the things that are stressing you out at work and when you get to work tear them up and tackle the day as it comes.

The top two biggest ways to overcome your fear of change is to communicate and stay positive. Strong communication can address and calm any fears you or others may have during the change. (SCHOLARSHIP) Additionally, knowing how transitions work and having realistic expectations as well as being flexible will help you overcome any fears of change. Debbie also spoke about creating teams that include people involved in the change at every level to brainstorm any problems that may arise and how to address them. It is also very important to take time every day to reduce your stress by meditation or exercise or prayer, whatever works for you. No matter what the change may be get involved in it and continue working to do whatever you can during the change to make the transition successful.

Scot also spoke on the 4 steps to thrive during change as discussed by author Jon Gordon in “The Shark and the Goldfish”. The steps include: embrace the wave of change, ride the wave of change, stay positive during change, and thrive because of change. Scot encouraged everyone to never stop learning and be open to change because it will make the transition easier. Most importantly make sure you walk the talk.

Scot ended the presentation with a powerful music video of being an overcomer called “Overcomer” by Mandisa.

2015-2016 AFWA Mentor Program

The AFWA Mentor Program was developed and is administered by the Wichita Chapter AFWA Membership Committee. Below are details of the program.

Program Objective:

- To facilitate the interaction between new and existing AFWA members in a one-on-one setting that may be more comfortable to new members than a larger group setting.
- For existing members to mentor new members on career paths, work/life balance, or other topics.
- To allow students and new members an additional networking opportunity that may assist in future career development.
- To encourage new members to become involved in AFWA committees and attend events.
- To serve as a "familiar face" at monthly meetings and other AFWA events. This may include the mentor sitting with their mentee during the first 1-2 program meetings.

Program Details:

- All participation (by mentors and mentees) is strictly voluntary.
- The Membership Director will oversee the Mentor Program and pair mentors with mentees based on certain factors (e.g. job type, career or personal interests, location).
- As new members join, the Membership Director will ask that new member about their interest in their program. If new members are interested, they will be paired with a mentor that is "in queue."
- Once per year, the Membership Director will arrange a lunch for all members participating in the Mentor Program. This will not be a hosted lunch (cost to be covered by each individual, or mentor may choose to cover the cost for their mentee).
- At the end of the program year, all mentors and mentees will be asked to complete a survey about the mentor program (likes, dislikes, suggestions, etc.)
- If the mentor and/or mentee determine that their mentoring relationship is not beneficial, either person may stop participating at any time. A new mentor/mentee can be assigned if this is desired.

Program Requirements:

- The mentor will be expected to reach out to their mentee within two weeks of mentor/mentee assignments.
 - The mentor and mentee will arrange their initial meeting at a date/time that works for both.
 - The mentor and mentee may agree to sit together at any upcoming program meetings, particularly if the mentee does not know any other members within the chapter.
 - It is recommended that the mentor and mentee meet quarterly (i.e. 4 times per year)
